

**AMENDMENT TO AGREEMENT  
FOR THE NORTHERN AREA OF THE COUNTY OF HUMBOLDT**

This is an amendment to the Agreement entered into on December 15, 1998, and to amendments thereto previously executed by and between the County of Humboldt (COUNTY) and Gregory and Christine Cain, (CONTRACTOR). The effective date of this Amendment is July 1, 2009.

**RECITALS**

WHEREAS, COUNTY and CONTRACTOR have entered into an Agreement for operation and maintenance of County-owned solid waste container sites; and

WHEREAS, COUNTY and CONTRACTOR have agreed to extend the existing Agreement;

WHEREAS, said Agreement allows for the adjustment of annual amount paid to the CONTRACTOR for solid waste services pursuant to the terms of Sections 16 and 18.

NOW, THEREFORE, IT IS AGREED as follows:

1. Section 2 entitled Term of Agreement is amended to read as follows:

Unless terminated pursuant to this Agreement this Agreement which commenced on October 1, 1998 through June 30, 2009, shall be extended for a period of three (3) months, commencing July 1, 2009 and terminating on September 30, 2009.

2. Payment Adjustment. The monthly amount paid to CONTRACTOR pursuant to above-referenced Agreement shall be shown in the Attached Exhibit A, effective July 1, 2009. This payment adjustment incorporates changes in the Consumer Price Index, hourly site costs and disposal costs as indicated in Exhibit A.
3. Except as modified herein or by prior amendments, the December 15, 1998, Agreement shall remain in full force and effect. In the event of a conflict between the provisions of this amendment and the original agreement, or any amendments thereto previously executed, the provisions of this amendment shall govern.







**AMENDMENT TO AGREEMENT  
FOR THE NORTHWESTERN AREA OF THE COUNTY OF HUMBOLDT**

This is an amendment to the Agreement entered into on December 21, 1982, and to amendments thereto previously executed by and between the County of Humboldt (COUNTY) and Gregory and Christine Cain (CONTRACTOR). The effective date of this Amendment is July 1, 2009.

**RECITALS**

WHEREAS, COUNTY and CONTRACTOR have entered into an Agreement for the handling and disposal of solid waste; and

WHEREAS, COUNTY and CONTRACTOR have agreed to extend the existing Agreement;

WHEREAS, said Agreement and State law allow for the adjustment of rates charged by CONTRACTOR for the handling of solid waste pursuant to said Agreement; and

WHEREAS, said Agreement provides for an annual adjustment to the collection rates, effective on July 1, based on the Consumer Price Index.

NOW, THEREFORE, IT IS AGREED as follows:

1. Section 2 entitled Term of Agreement is amended to read as follows:

Unless terminated pursuant to this Agreement this Agreement which commenced on December 21, 1982, extended effective October 1, 1998 and terminating on June 30, 2009, shall be extended for a period of three (3) months, commencing July 1, 2009 and terminating on September 30, 2009. The term may be further extended by the mutual agreement of the Parties and which shall comply with Section 521-6(c) Chapter 1 of Division 2 of Title V of the Humboldt County Code.

2. RATE DECREASE. The rates which may be charged by CONTRACTOR pursuant to the rate provisions of the above-referenced Agreement shall be as shown in the attached Exhibit A, effective July 1, 2009. These rates reflect a decrease due to the annual adjustments for changes in the Consumer Price Index.
3. Except as modified herein or by prior amendments, the December 21, 1982, Agreement shall remain in full force and effect. In the event of a conflict between the provisions of this amendment and the original agreement, or any amendments thereto previously executed, the provisions of this amendment shall govern.
