

# Central Committee and County Council Members Primary Election Calendar March 5, 2024

This calendar is intended to be a general-purpose resource for those seeking information for the Presidential Primary Election on March 5, 2024. We have tried to make it as useful and accurate as possible, but it should not be relied upon in place of the Elections and/or Government Codes for statutory guidance.

<p><b>September 12, 2023</b></p> <p>E-175</p>	<p><b>County Central committees – Republican, Democratic parties</b></p> <p>By this date, the county elections official shall compute the number of members of the Democratic and Republican County Central committee to be elected in each supervisor district. Elections Code says no later than January 31.</p> <p style="text-align: right;">EC 7226, 7421</p>
<p><b>September 29 – December 8, 2023</b></p> <p>E-158 – E-88</p>	<p><b>Nomination Period for Central Committee Candidates</b></p> <p>Between these dates, candidates for central committee, including incumbents running for re-election, must file their nomination papers with 20-40 signatures from voters registered with your party and in the district where you are running. Forms are obtained from and filed with the Humboldt County Office of Elections at 2426 6<sup>th</sup> Street, Eureka.</p> <p style="text-align: right;">EC 8020, 8062</p>
<p><b>September 29 – December 8, 2023</b></p> <p>E-158 – E-88</p>	<p><b>Declaration of Candidacy Period</b></p> <p>During this period, all candidates must file their declarations of candidacy along with their candidate statements of qualifications if they choose to submit one. Forms are obtained from and filed with the Humboldt County Office of Elections.</p> <p style="text-align: right;">EC 8020, 8040, 8028, 8100</p>
<p><b>November 13 – December 8, 2023</b></p> <p>E-113 – E-88 (plus extension period, if any)</p>	<p><b>No Candidate May Withdraw</b></p> <p>No candidate whose Declaration of Candidacy has been filed for any primary election may withdraw as a candidate at that primary election.</p> <p style="text-align: right;">EC 8800</p>
<p><b>December 9 - December 13, 2023</b></p> <p>E-87 – E-83</p>	<p><b>Extension of Nomination Period</b></p> <p>Extension period for anyone other than the incumbent to file a declaration of candidacy and nomination petition if the incumbent did not file by December 8. This provision does not apply if there is no incumbent eligible to be elected</p> <p style="text-align: right;">EC 8024</p>

<p><b>December 9 – December 13, 2023</b></p> <p>E-87 – E-83</p>	<p><b>Extension of Declaration of Candidacy Period</b></p> <p>Extension period for anyone other than the incumbent to file a declaration of candidacy and nomination documents if the incumbent did not file by December 8, 2023. This provision does not apply if there is no incumbent eligible to be elected.</p> <p>EC 8024, 8028</p>
