The Humboldt County Office of Elections has received your vote by mail or provisional envelope. The signature you provided does not match the signature(s) on file in your voter record. By law, a voter's signature must be verified before the ballot may be counted.

Your signature may have changed over time.

To ensure that your vote by mail or provisional ballot will be counted, this Signature Ballot Statement must be received by the Humboldt County Office of Elections no later than 5:00pm two days prior to the **certification of the Presidential Primary Election.**

- **Mail your signed completed statement in the enclosed envelope.** The Signature Verification Statement must be received at our office before 5:00 pm two days prior to the election certification.

This must be done before by 5:00 pm two days prior to **certification of the Presidential Primary Election.**
- **Deliver your signed statement on Election Day** to a polling location in Humboldt County or ballot drop box location before the close of polls (8:00 pm) on Election Day, March 5, 2024.

Please note that the signature provided on the completed Statement may be added to your registration record for signature comparison purposes in future elections.

SIGNATURE VERIFICATION STATEMENT

I, _____ (**print name**), am a registered voter of Humboldt County, State of California. I declare under penalty of perjury that I returned a vote by mail ballot and that I have not and will not vote more than one ballot in this election. I am a resident of the precinct in which I have voted, and I am the person whose name appears on the vote by mail or provisional ballot envelope. I understand that if I commit or attempt any fraud in connection with voting, or if I aid or abet fraud or attempt to aid or abet fraud in connection with voting, I may be convicted of a felony punishable by imprisonment for 16 months to three years. **I understand that my failure to sign and return this statement means that my vote by mail or provisional ballot will be invalidated.**
