

ORDINANCE NO. 1147

AMENDING ORDINANCE NO. 777
(THE BUILDING, PLUMBING AND ELECTRICAL ORDINANCE
RELATING TO PARKING)

The Board of Supervisors of the County of Humboldt do ordain
as follows:

SECTION 1. Section 6.6 is added to Ordinance No. 777 to read
as follows:


"SECTION 6.6. PROVISIONS FOR PARKING.

The following parking requirements are and shall be made
a condition to a building permit for any building erected or
any new or extended use commenced after the effective date of
this Ordinance. If the improved road section is less than
40 feet, either improved off-street parking must be provided
for five (5) vehicles, or a parking lane must be constructed
along the frontage of the lot. The parking lane need not
accommodate more than three (?) vehicles if the lot frontage
exceeds 120 feet. The construction standards for the parking
lane shall be specified by the Department of Public Works in
accordance with the Humboldt County Subdivision Ordinance No.
_____."

SECTION 2. This ordinance shall become effective thirty (30)
days after the date of this enactment.
