### Tier Definitions\*\*

Community Risk	Individual Risk	Adjusted Case Rate	Positivity Rate
<b>Widespread</b> Tier 1	Widespread outbreak that is growing with many undetected cases. Take strong measures to limit all contact.	<b>More than 7</b> daily new cases (per 100k)	<b>More than 8%</b> positive tests
<b>Substantial</b> Tier 2	Many cases with conditions for community spread, with many undetected cases likely. Limit everyday activities to increase safety.	<b>4 - 7</b> daily new cases (per 100k)	<b>5 - 8%</b> positive tests
<b>Moderate</b> Tier 3	Moderate number of cases with majority of cases from a known source. Increase efforts to limit personal exposure.	<b>1 - 3.9</b> daily new cases (per 100k)	<b>2 - 4.9%</b> positive tests
<b>Minimal</b> Tier 4	Cases are somewhat sporadic, and contact tracing can be used to control the virus. Take everyday enhanced precautions.	<b>Less than 1</b> daily new cases (per 100k)	<b>Less than 2%</b> positive tests

\*Data used by the state to determine tier assignment. Local and state numbers rarely align because local data is updated daily, whereas the state's data is calculated over a seven-day period with a seven-day lag and is updated each Tuesday.

\*\*The state's "Blueprint for a Safer Economy" includes a Health Equity Metric, which requires having similar positivity rates across a county to demonstrate that no community is disproportionately impacted by COVID-19. Meeting this metric is necessary before movement into a less restrictive tier, and in some instances may allow earlier movement. Read more about the [Health Equity Metric](#).

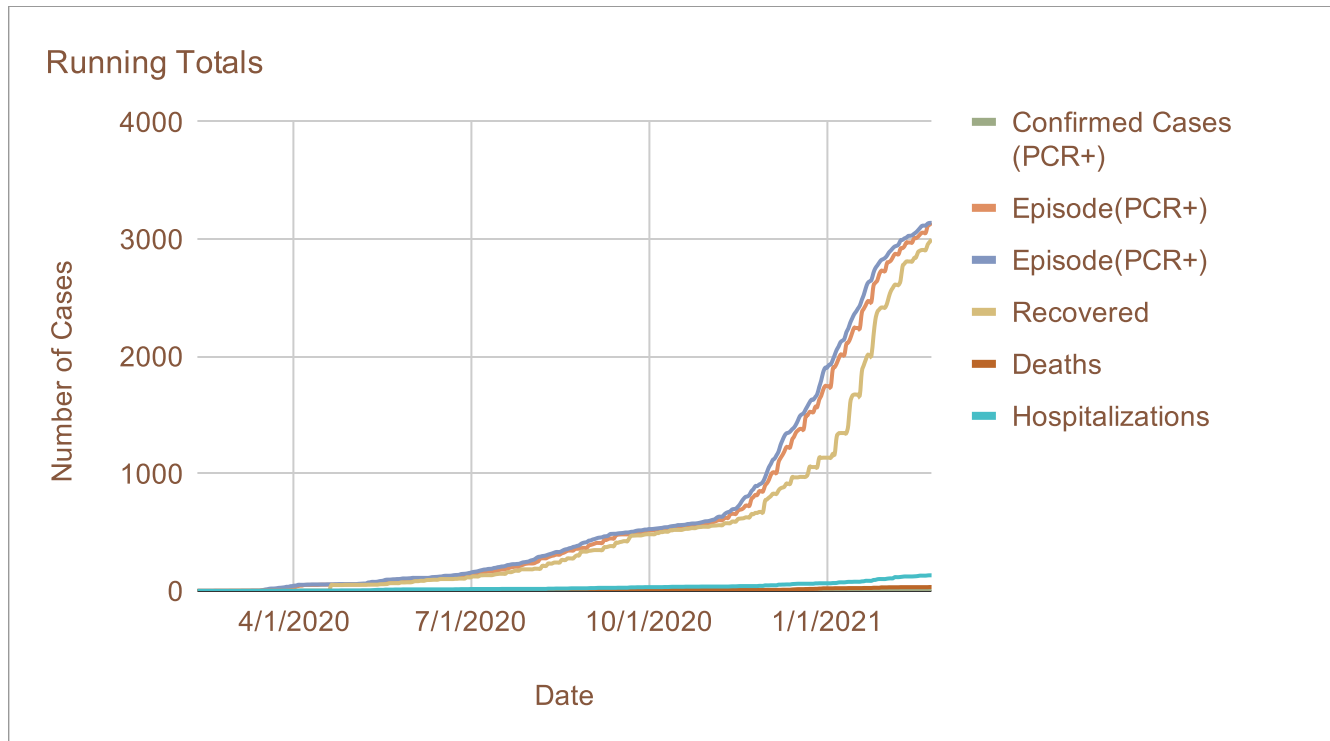

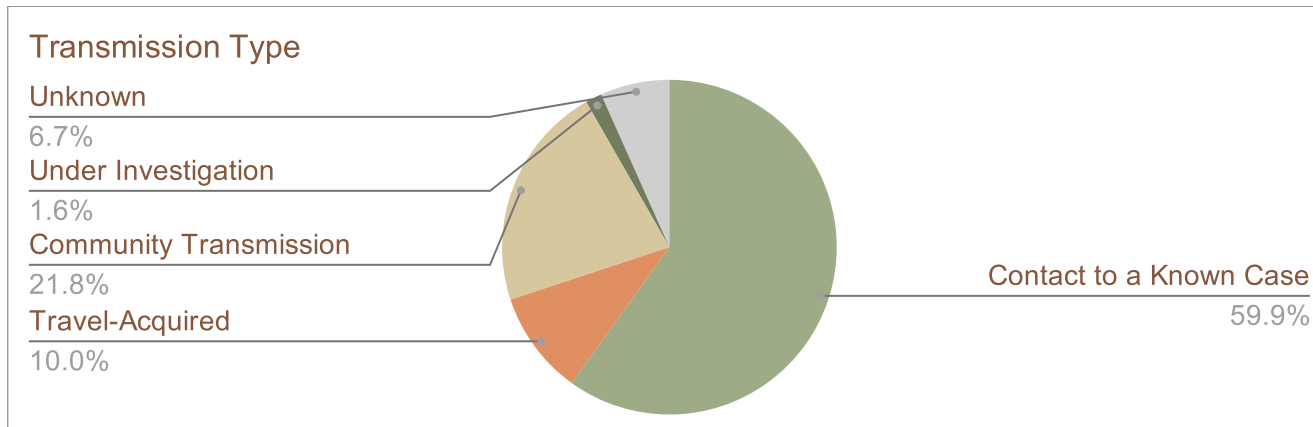

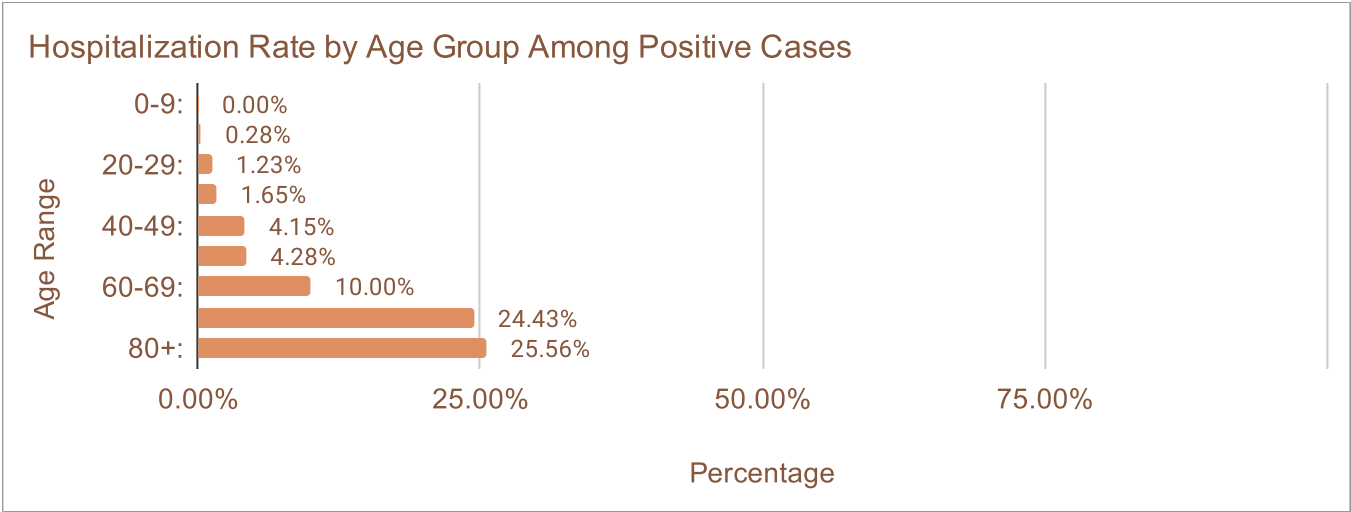

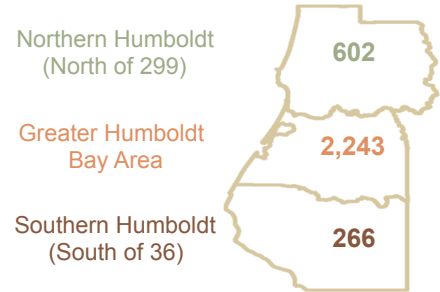


Cumulative Positive Test Rate

### Geographic Distribution

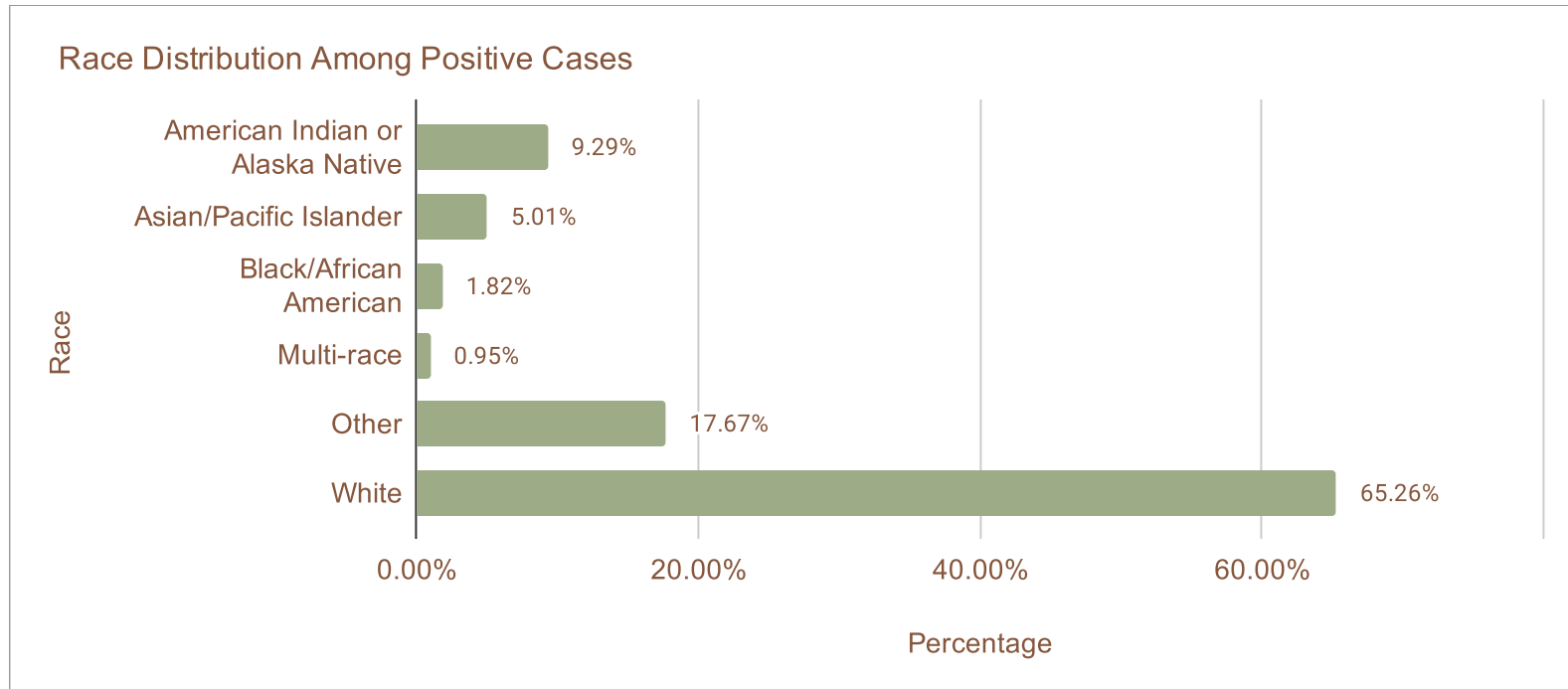

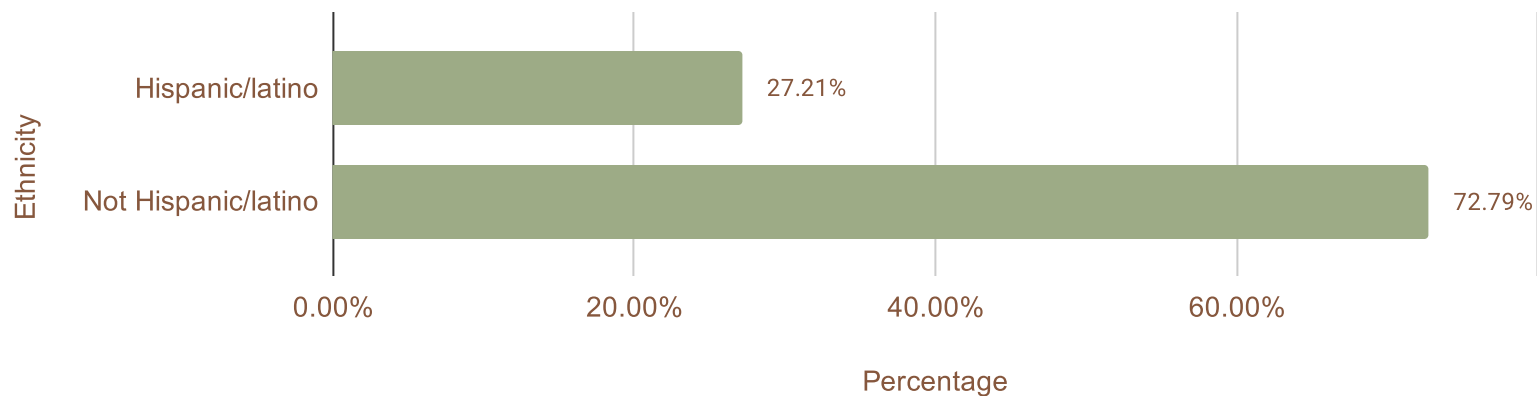

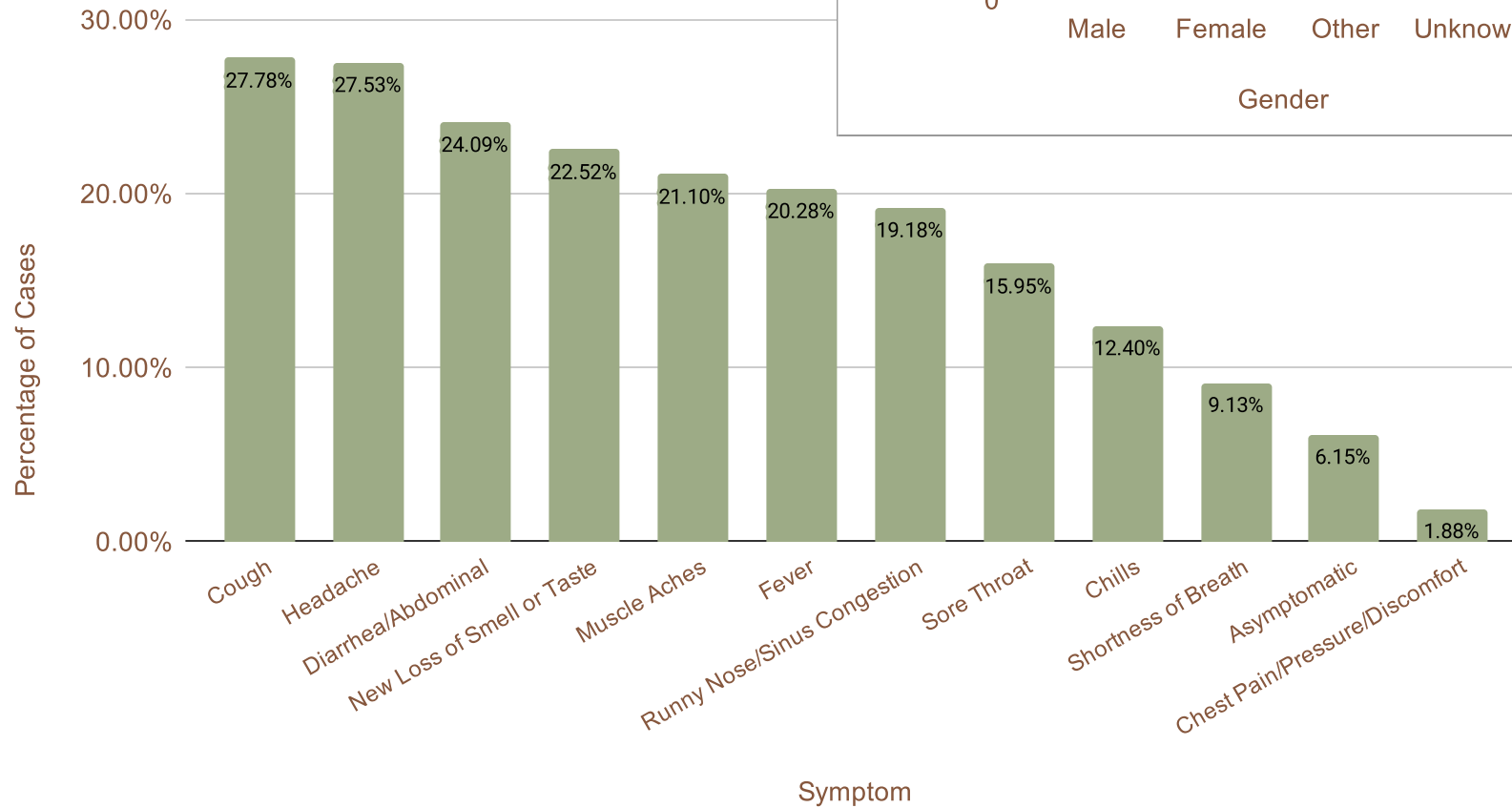

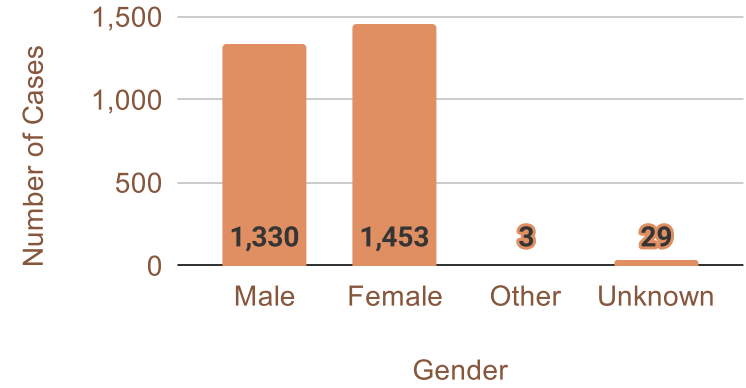

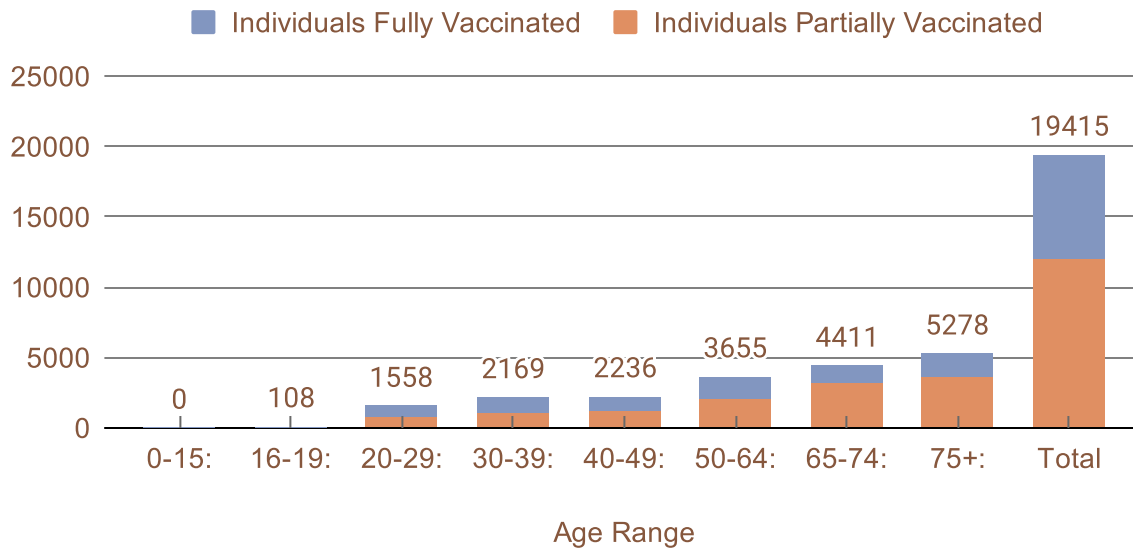

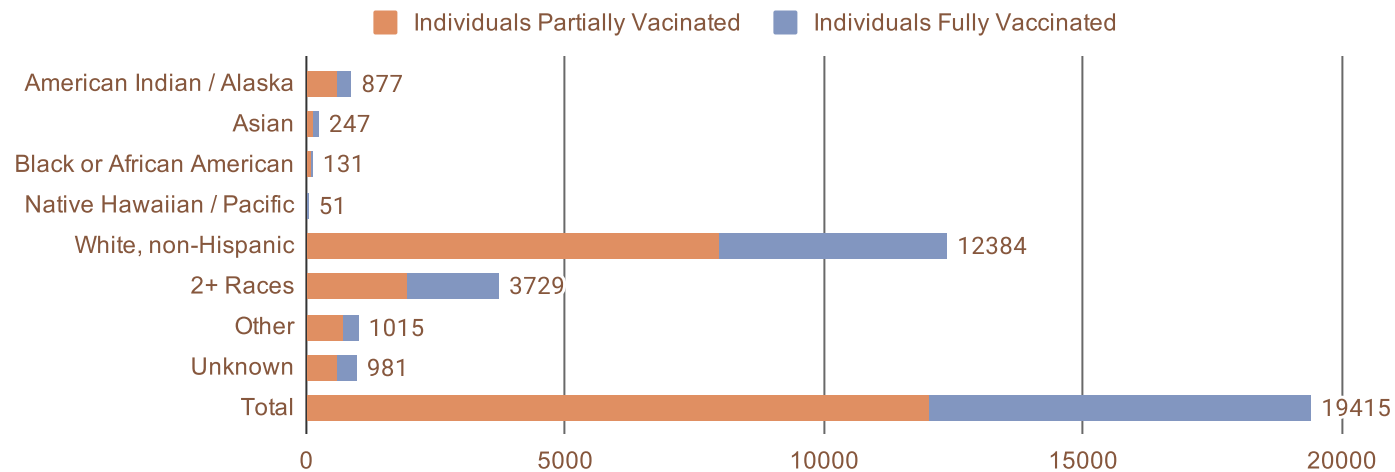
Individuals Partially and Fully Vaccinated by Age Group

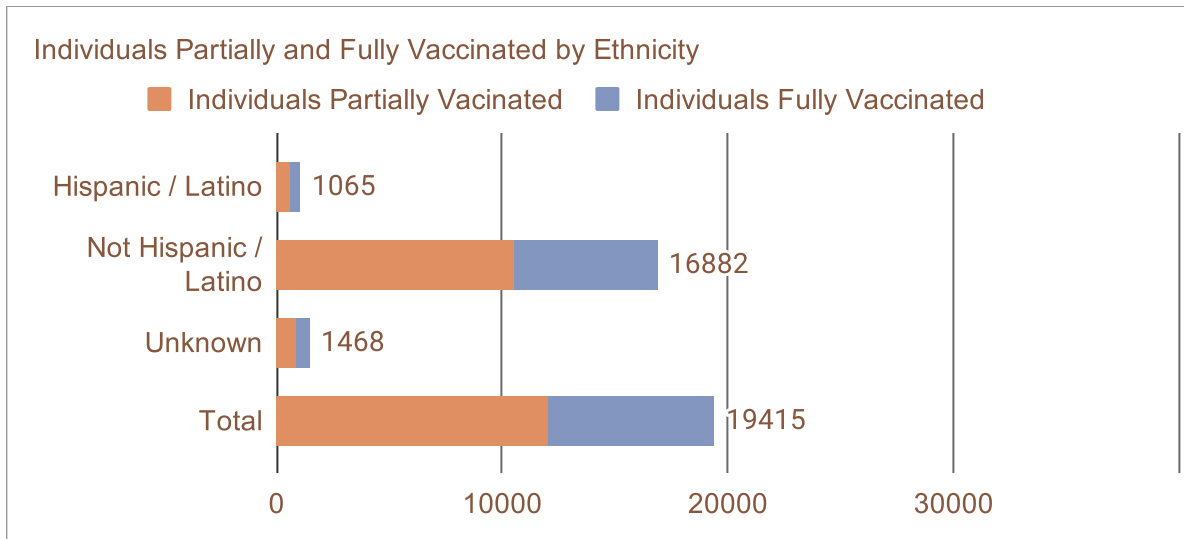

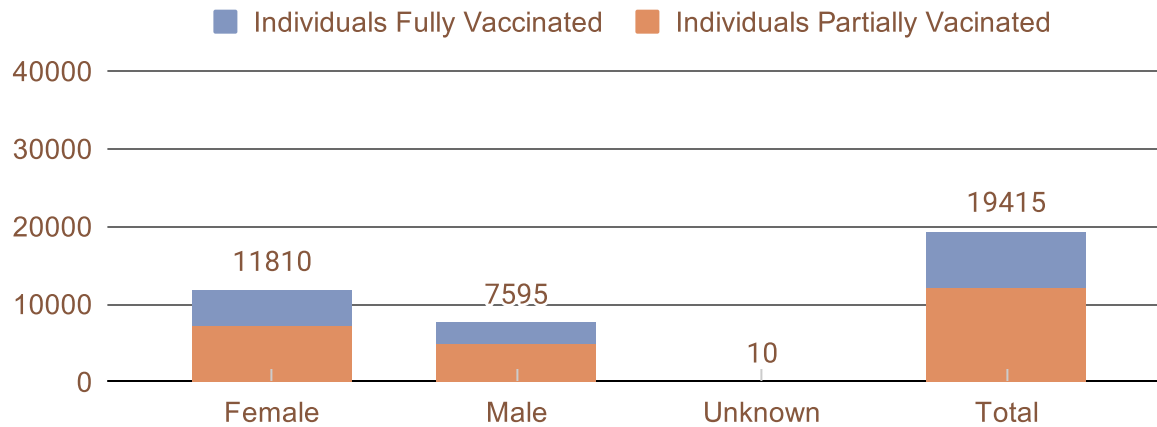
