THE HUMBOLDT COUNTY SHERIFF'S DEPARTMENT IS CURRENTLY INVESTIGATING A MISSING PERSONS REPORT ON ANDREA WHITE. ANDREA WHITE WAS LAST SEEN IN EUREKA ON JULY 31, 1991. WHITE IS A RESIDENT OF HOOPA AND IS DESCRIBED AS AN INDIAN FEMALE ADULT, 5-0 TALL, 115 LBS, BROWN HAIR AND BROWN EYES. WHITE HAS NUMEROUS RELATIVES IN THE HOOPA AND EUREKA AREA, INCLUDING FOUR CHILDREN IN HOOPA. ANDREA WHITE IS 22 YEARS OLD AND HAS NOT BEEN SEEN OR HEARD FROM BY ANY FAMILY MEMBER SINCE COMING TO EUREKA ON JULY 31, 1991.

THE HUMBOLDT COUNTY SHERIFF'S DEPARTMENT IS CURRENTLY ASKING ANYONE WITH ANY INFORMATION ON ANDREA WHITE'S LOCATION TO CALL THE SHERIFF'S DEPARTMENT, DETECTIVE BUREAU AT 445-7301. THE SHERIFF'S DEPARTMENT HAS NOT RULED OUT FOUL PLAY IN THE DISAPPEARANCE OF ANDREA WHITE AND IS AGGRESSIVELY INVESTIGATING HER DISAPPEARANCE.

THE HUMBOLDT COUNTY SHERIFF'S DEPARTMENT IS CONTINUING TO INVESTIGATE THE DISAPPEARANCE OF ANDREA WHITE. ADDITIONAL INFORMATION HAS BEEN DEVELOPED THAT WHITE WAS LAST OBSERVED ON HIGHWAY 299 ON JULY 31, 1991. AT THAT TIME, WHITE WAS HITCHHIKING EASTBOUND JUST EAST OF THE BLUE LAKE EXIT. WHITE WAS KNOWN TO BE AT THAT LOCATION AT ABOUT 1:30 P.M. WHITE HAD TOLD SEVERAL PEOPLE SHE MET THAT DAY, THAT SHE WAS RETURNING HOME. AS OF THIS TIME NO FAMILY MEMBERS, FRIENDS, OR ACQUAINTANCES HAVE SEEN ANDREA WHITE, SINCE THE JULY 31ST SIGHTING ON HIGHWAY 299.

ON AUGUST 15, 1991, THE HUMBOLDT COUNTY SHERIFF'S DEPARTMENT ASISTED BY THE CALIFORNIA HIGHWAY PATROL HELICOPTER, BASED IN REDDING, CONDUCTED A SEARCH OF HIGHWAY 299, AT THAT TIME THE AREA BETWEEN BLUE LAKE AND WILLOW CREEK ADJACENT TO HIGHWAY 299 WAS CHECKED FOR ANY POSSIBLE EVIDENCE AS TO THE DISAPPEARANCE OF ANDREA WHITE. NOTHING WAS FOUND DURING THE SEARCH WHICH WOULD ASSIST IN THE INVESTIGATION OF WHITE'S DISAPPEARANCE.

AT THIS TIME THE HUMBOLDT COUNTY SHERIFF'S DEPARTMENT IS REQUESTING ANYONE WITH ANY INFORMATION ABOUT ANDREA WHITE OR HER ACTIVITIES ON JULY 31, 1991, AFTER SHE LEFT THE BLUE LAKE AREA, TO CONTACT THE SHERIFF'S DEPARTMENT.

THE HUMBOLDT COUNTY SHERIFF'S DEPARTMENT IS CONTINUING THEIR INVESTIGATION INTO THE DISAPPEARANCE OF ANDREA "CHIC" WHITE. ANDREA WHITE HAS NOW BEEN MISSING 35 DAYS WITH NO CONFIRMED CONTACT WITH ANY FAMILY MEMBER.

THE SHERIFF'S DEPARTMENT NOW BELIEVES THAT FOUL PLAY IS STRONGLY INDICATED IN WHITE'S DISAPPEARANCE. DUE TO THE SUSPICIOUS NATURE OF WHITE'S DISAPPEARANCE, THE SHERIFF'S DEPARTMENT IS STRONGLY URGING ANYONE WHO HAS SEEN WHITE OR HAS KNOWLEDGE OF WHITE'S WHEREABOUTS TO CONTACT DETECTIVE WALKER AT THE HUMBOLDT COUNTY SHERIFF'S DEPARTMENT.

THE LAST KNOWN LOCATION OF WHITE WAS ON JULY 31, 1991 AT 1:30 PM, HITCHHIKING ON HIGHWAY 299 EASTBOUND TOWARDS HOOPA.

THE HOOPA TRIBAL COUNCIL IS CURRENTLY OFFERING A \$1,000.00 REWARD FOR INFORMATION LEADING TO THE LOCATION OF ANDREA WHITE. ANYONE RECOGNIZING WHITE OR THE ATTACHED PHOTOGRAPH IS URGED TO RESPOND.
